**Subj: FY2002 LEGISLATIVE PAY CHANGE IMPLEMENTATION**

**Introduction** This E-Mail ALPERSRU provides the status of system changes necessary to implement the FY2002 legislative pay change. BAH Type II rates are provided so PERSRUs can input new rental charges for members assigned to inadequate government quarters.

**Entitlement Rate Changes** HRSIC has implemented the following legislative pay changes announced in reference (a), which became effective on 1 October 2001 and 1 January 2002. A summary follows:

Enlisted Clothing Maintenance Allowance (CMA) Changes	1 Oct 2001	15 Oct 2001
Retroactive to 10/1/00, qualified reserve officers can receive both the \$400 initial and \$200 additional uniform allowance.	1 Oct 2000	On 1 Mar 2002, HRSIC will pay officers who qualified between 1 Oct 2000 and 31 Dec 2001. For officers who qualify on or after 1 Jan 2002, PERSRU must submit Officer Uniform Allowance transaction (Claim Code E) per page 2-A-227, reference (b).

The change in BAH Type II rates effects the rental charge for Inadequate Government Quarters.

- PERSRUs must submit a "Start/Resume Pay And Allowances, Change Rental Charge For Inadequate Gov't Quarters (P607)" transaction, with an effective date of 01 January 2002 for members assigned to inadequate government quarters.
- Instructions for completing the P607 transaction can be found on page 2-A-172 of reference (b).
- BAH Type II rates, which are used to compute the rental charge, are listed in enclosure (1) to this E-Mail ALPERSRU.
