

ITEMS PROHIBITED FOR MOVEMENT AT GOVERNMENT EXPENSE
(Appendix A, JFTR)

THE FOLLOWING ITEMS ARE NOT AUTHORIZED AS PERSONNEL PROPERTY FOR SHIPMENT AT GOV'T EXPENSE BY COMMERCIAL METHOD OR SELF PROCURED MOVE (DITY):

- AIRPLANES
- PROPANE TANKS (INCLUDING EMPTY TANKS)
- GOLD AND SILVER BULLION
- CASH
- PERISHABLE FOODSTUFFS
- LIVE PLANTS
- TAX-FREE CIGARETTES
- ALCOHOLIC BEVERAGES (*SEE NOTE 1*)
- PETS
- GROCERY PROVISIONS (OTHER THAN THOSE FOR CONSUMPTION BY YOURSELF AND/OR YOUR DEPENDENTS)
- ARTICLES FOR SALE/RESALE
- DANGEROUS MATERIALS SUCH AS SCUBA TANKS WHEN LOADED WITH COMPRESSED AIR
- LOADED FIREARMS
- AMMUNITION OF ANY TYPE
- PHOTO FLASH BULBS
- AEROSOL CANS
- FLAMMABLES AND ACIDS
- ANY TYPE OF PASSENGER-CARRYING VEHICLES (FOUR WHEEL VARIETY)
- GLIDERS (*SEE NOTE 2*)
- TRAILER CAMPER
- FIRE EXTINGUISHER
- LARGE OUTDOOR PLAYHOUSES/DOLL HOUSES WHICH HAVE NOT BEEN DISASSEMBLED
- FIREWOOD

THE FOLLOWING ITEMS ARE NOT AUTHORIZED AS PERSONAL PROPERTY FOR SHIPMENT AT GOV'T EXPENSE BY COMMERCIAL METHOD OR SELF PROCURED MOVE (DITY) FOR

AIR FORCE PERSONNEL:

- KENNELS AND OTHER STRUCTURES SPECIFICALLY BUILT AS ANIMAL SHELTERS WHICH EXCEED THE DIMENSIONS OF 4X3X3 FEET
- UTILITY AND STORAGE SHEDS OF ANY TYPE THAT ARE NOT DISASSEMBLED PRIOR TO PACKING
- BUILDING MATERIALS (I.E. LUMBER, CONCRETE BLOCKS, BRICKS AND CEMENT UNLESS USED AS FURNITURE ITEMS AS IN THE HOME.)

NOTE 1: ALCOHOLIC BEVERAGES ARE AUTHORIZED SUBJECT TO ACCEPTANCE BY THE CARRIER, AND STATE/COUNTY LAWS.

NOTE 2: A HANG GLIDER MUST WEIGH LESS THAN 155 LBS., WHILE A POWERED GLIDER MUST WEIGH LESS THAN 250 LBS.; BE LIMITED TO 5 U.S. GALLONS OF FUEL, AND HAVE A MAXIMUM SPEED OF NOT MORE THAN 55 KNOTS. BOTH POWERED AND UNPOWERED ULTRA LIGHT GLIDERS ARE LIMITED TO A SINGLE OCCUPANT. GLIDERS EXCEEDING THE ABOVE CRITERIA ARE CONSIDERED AIRPLANES.
